## Wavefront Energy and Environmental Services Inc. Update

EDMONTON, Alta October 21, 2004 Wavefront Energy and Environmental Services Inc. (TSX Venture Exchange: WEE), wishes to update shareholders on its focused strategic plan to advance its core technology, Pressure Pulse Technology (PPT) in the oil industry. Management believes PPT is very timely given current crude oil prices and the overriding concern amongst oil analysts regarding the world's scarce surplus production capacity, or oil supply buffer.

PPT entails using a downhole tool to create low amplitude fluid pressure waves in the reservoir thereby improving the efficiency of fluid injection and mobility. PPT has shown indications of *increased oil production and increased oil cuts*. The Company is currently in discussions with several major oil companies regarding the potential installation of PPT systems in waterflood projects throughout North America. Additionally, the Company is also pursuing opportunities for the application of PPT to improve the effectiveness of reservoir acidizing and diversion, and oil field produced water disposal.

The Company also wishes to advise that it has identified opportunities for the acquisition of mineral rights, and joint ventures, which may be deemed economically suitable for the application of PPT. Currently the Company is assessing several reservoirs in Texas, Wyoming, and Montana. The acquisition of properties and joint ventures is in keeping with the Company's strategy for maximizing the economic potential of PPT outlined in a previous announcement dated June 30, 2004.

While the Company is advancing its PPT initiatives, it continues to seek additional opportunities in reservoir monitoring. The Company is entering the fabrication stage of its proprietary designs for the installation of the monitoring projects that were announced on July 26 and 27, 2004 respectively. With the completion of these projects, the Company will recognize revenue of approximately \$800,000.
